Update from NEoLCIN

Cost-effective commissioning of end of life care


In 2015/16, the Health Economics team in Public Health England (PHE) commissioned a programme of work to enable Clinical Commissioning Groups (CCGs), local authorities, and other decision makers to better understand the economic case for increasing investment in prevention and early intervention. One of the areas that was identified as a priority were the services and care provided to patients who were diagnosed as being or nearing the end of their lives, as a result of a terminal illness.

Today we have published a number of products to support commissioning decisions for end of life care services. These include:

A report ‘Understanding the health economics of palliative and end of life care’.

The first half of the report presents the findings of a review of the available literature on the costs and effectiveness of different initiatives and schemes designed to improve patients and carers experiences at the end of the patient’s lives. The second half of this report describes the new end of life care economic tool and the methodology underpinning this tool.

An end of life care analytical tool. This interactive tool is made up of two components. The first provides a summary of the costs, impacts and wider issues associated with different interventions and services for providing care and support for patients at the end of their lives. The second component enables the user to explore the potential trade-offs associated with shifting resources and activity away from secondary care into primary, community and social care settings.

Cost-effective commissioning of end of life care—continued

The end of life care analytical tool user guide. This document provides a step-by-step guide to the end of life care economic tool.

These products will be of great importance for decision-makers. They will help them when they are considering the potential improvement, or indeed the potential decline, in the quality and safety of care, and patient experience, in conjunction with the net financial implication, when considering the implementation of interventions. Moreover, they will assist stakeholders when looking at current capacity of care provision and whether it can adequately cope with a potential influx of primary, community and social care activities for end of life care.

Evaluation of the End of Life Social Action Fund

The independent evaluation report of the [End of Life Social Action Fund](#) has been published. The fund was launched by the Cabinet Office in 2014, and was evaluated by Lancaster University's International Observatory on End of Life Care and the Institute for Volunteering Research. This report looks at the key findings from the evaluation, and aims to provide lessons for similar interventions in the future.

End of life care must be for the whole family not just the dying child, says NICE in new guidance

NICE have produced new guidance on [End of life care for infants, children and young people with life-limiting conditions: planning and management](#).

Dying at home or in hospital dependent on wealth, location and number of diseases

Researchers from King's College London's Cicely Saunders Institute have published a new study in BMC Medicine. They studied a national data set of all deaths from two common groups of respiratory diseases - Chronic Obstructive Pulmonary Disease (COPD) and Interstitial Pulmonary Diseases (IPD), covering 380,232 people over 14 years. In this study, which was funded by the National Institute for Health Research, the team looked at the impact of a national end of life care strategy to reduce deaths in hospital.

Getting Real About the National Commitment

Friday 10 March 2017, London

In July 2016 the Government made a new National Commitment on end of life care. This was the most comprehensive and significant policy announcement for palliative and end of life care since the 2008 strategy, and will affect work across end of life care. The National Council for Palliative Care's conference: Getting Real About the National Commitment is the first conference looking at this in detail. End of Life Care: Legal Issues Masterclass

Monday 13 March 2017, De Vere West One Conference Centre, London

This one-day course will provide healthcare practitioners involved in palliative and elderly care an introduction to the legal framework in which they practice. The day will cover the basic statutory and common law framework that governs how a healthcare professional can treat and care for those at the end of their lives. Through case studies the implications of best interest assessments and the Deprivation of Liberty Safeguards (DoLS) will be explored.
